The unaudited Net Tangible Asset (NTA) backing of the Adelaide Managed Funds Asset Backed Yield Trust (AYT) as at 30 June 2015 is 3.57 cents per Unit.

This NTA per Unit includes the impact of the announced but unpaid estimated income distribution of 0.7000 cents per Unit payable on 10 September 2015.
