The unaudited Net Tangible Asset (NTA) backing of the Adelaide Managed Funds Asset Backed Yield Trust (AYT) as at 31 July 2015 is 3.57 cents per Unit.

This NTA per Unit includes the impact of the announced but unpaid estimated income distribution of 0.7000 cents per Unit payable on 10 September 2015.

The actual distribution amount will be confirmed to Unitholders in conjunction with the release of AYT's full year results, which is expected to occur in late August 2015.
